## Guidelines

### Arts & Crafts Vendor Eligibility

The goal of the Red Boiling Springs Folk Medicine Festival is to pass on knowledge, skills, and traditions that ensure the survival of folk activities, from: old-time medicine and natural healing arts to arts and crafts that demonstrate the traditional, handmade way of not only creating art but useful household items. We see the Folk Medicine Festival as an opportunity to encourage creative expression and foster a sense of community. No garage sale/ flea market style items are acceptable only handmade, traditional crafts and artwork.

### Booth and Set-up Requirements

All artists will be given a 10'x10' space for their booth. Artists will provide their own tables, chairs, and display materials. It is also strongly suggested that artists make provisions for shelter (i.e. tents or awning cover) in case of rain or hot sun. There will be no indoor vendor booth spaces. Artists will be allowed to unload supplies on the park area, but parking itself will not be allowed in market area. Parking spaces will be available in the parking lot of the Gas Hut adjacent to the Palace Park. Each vendor will be assigned a number. **Set-up time** is Saturday morning from 7:00 a.m. until 9:00 a.m. The market will open promptly at 9:00 a.m. Booths must remain setup until the close of the market at 5:00 p.m. on Saturday.

### Artists' Costs

There will be a one-time \$40 fee for booth rental for the market. Enclose a "completion check" of \$25 with your registration form. The "completion check" will be returned to you at 5:00pm day of the festival. If you leave early, the Festival retains this check. All sales are for the artists' benefit and no further commission is required by the festival. The \$40 booth fee and \$25 completion check should be two separate checks, please and should be submitted with application below. All checks should be made payable to Vision 2020 Inc. No refunds after May 1, 2018
